Enter our photo contest for the cover of Salina-Spavinaw Telephone Co.'s 2012 directory and compete for the grand prize of a laptop computer. Join in the fun and submit your photos portraying the natural beauty and scenic settings that abound in SST's service area.

Additional cash prizes totaling \$400 will be awarded in 3 categories – ages 12 and under, ages 13-18 and ages 19 and above. Three places will be awarded in each category with cash prizes of \$75 for 1st place, \$50 for 2nd place, and, \$25 for 3rd place winners.

We launched our online photo contest last year and received hundreds of entries. One or more of the winning photos will be featured on the May 2012 directory cover and all winning photos will appear in full color in the directory's community pages.

Contest Rules and Eligibility:

Entries are open to amateur photographers of all ages who are current SST subscribers or who are family members residing within the subscriber's household. Limit 3 photographs per household. Photos must be in color and have been shot within SST's service territory within the past three years.

Photos should depict the seasons or scenic beauty of SST's service area. Images could include lakes, woods, farms, flowers, recreational areas, agriculture, wildlife, or points of local interest. Photos should be submitted digitally, have a resolution of at least 300 dpi, and be in .tif, .jpg, or .psd format.

*For those unable to submit online: Photo prints may be submitted at our Salina or Kansas offices. A completed entry form must accompany **each** photo. Forms can be picked up at our offices or printed at www.sstelco.com.*

NOTE: Previous grand prize winners are ineligible for grand prize but may compete for cash prizes.

Photo must have been taken by person submitting the entry. No persons, trademarks, commercial names, or advertisements may appear in photo.

Employees of SST and residents of their households are not eligible to enter.

Use of Photos

Persons submitting photos agree that SST may use photos for its directory, website, newsletter or other publications or printed materials. Published photos will include photographer credit and photo description.

Judging

Winners will be notified by Jan. 31st. Decisions by SST, which reserves the right to accept or reject any or all entries, are final. *Prints may be picked up after Feb. 1st.*
